Scheduled Maintenance of ECC's clearing system SMSS

Due to preparation steps ECC's clearing system SMSS and FTP Server will not be available on Saturday 27.04.2024 from 09:00 CET to approximately 17:30 CET. This includes the non-availability of provision of reports (Trade Reports, Delivery Reports), report downloads from ECC FTP Server and Member Area as well as the access to ECC Member Area. As soon as the maintenance is completed, ECC will provide all reports. Please ensure to collect all necessary information before start of the maintenance work.

Change of ECC FTP Server

Due to ongoing improvements, we will migrate the ECC FTP Server. From **27 April 2024** onwards the production environment of the ECC FTP Server with the URL **ftps.ecc.de** will be mapped to a new IP address and will be reachable with the default protocol ports only. If you are accessing the ECC FTP Server via **ftps.ecc.de** you will be routed to the new IP from **27 April 2024** onwards, so there is no further action necessary.

However, if you are using the old IP address to access the ECC FTP Server, please adjust your connection parameters (ideally via the URL named above). In any case you should contact your IT department to adapt your company's firewall to the new IP addresses accordingly:

New availability durations for public data

Historic data on ECC FTP Server ECCPUBLIC like Contract Detail files, Risk Parameter files or SPAN files currently date back several years. The aforementioned data will be continuously curtailed to the last 90 days.

New availability durations for member specific reports

The availably of member specific reports subscribed from the ECC Member Area will be harmonized on all distribution channels. Download-links send as well as the data on ECC's FTP Server will be continuously available for the last 30 days.

Both changes on the time schedules on the availability of member specific reports and public data are unrelated to the reports that are provided through the Common Report Engine. Here the regular times and durations of reports prevail.
