

# **SEMOpx Website Enhancements**

# September 2021

#### 1. Aggregate Bid/Ask Curve publication under Static Reports

**Description:** Updated publication of the Bid/Ask Curves to combine the Ireland and Northern Ireland curves together, and publish the curves directly after each auction rather than D+1.

This modification has been reflected in the <u>SEMOpx Data Publication Guide v7.1</u>, with the change referenced in section 6.2.4: Bid/Ask Curves. The new format of the report "EA-004 Bid/Ask Curve" will be available in the <u>Market Data>Reports>Static Reports</u> section of the SEMOpx website via manual download or API, within 2 hours of auction publication.

#### 2. Static Reports section for REMIT Files

**Description:** To automate the upload of SEMOpx REMIT files to the SEMOpx website and to allow API download of the files by members.

On a daily basis SEMOpx submit REMIT files on behalf of members for both Auctions and Continuous Markets. Copies of these REMIT files will now be automatically published to the SEMOpx website, in the *Market Data>Reports>REMIT Reports* section. The reports can then be downloaded manually or using API. REMIT reports will be maintained in the library for 1 year and then removed.

This replaces the previous method of monthly zip files of remit reports that was published to the "Document Library".

### 3. Longer retention periods for reports on the website

**Description:** To extend the data retention for <u>"Static Reports"</u> from 2 months to 1 year, specifically the following reports:

- EA-001 ETS Market Results,
- EA-002 ETS Bid File,
- EA-003 Block Bid Order File,
- EA-004 Bid/Ask Curves,
- EA-006 Exchange Transparency,
- EA-007 Intraday Market Results Trade,
- EA-008 Intraday Market Results Order File, and
- EA-009 Intraday Market Results Statistics.

### 4. Intraday Continuous Order files to be published "On Receipt"

**Description:** To correct the publication timing for the report "EA-008 Intraday Market Results Order" to D+1, to ensure SEMOpx are in line with the SEMOpx Rules and Data Publication Guide.

The <u>SEMOpx Data Publication Guide</u> defines that report EA-008 is published on a D+1 basis, relative to the trading day. The report was being published on a D+2 basis.

## 5. Market Message Filter & Display Enhancements

**Description:** To remove both the "Category" and "Run Type" filters from the columns displayed on the <u>Market Messages page</u> on the SEMOpx website, as they are not relevant for SEMOpx market messages.

## 6. Document Library Catalogue and Search Enhancements

**Description:** To enhance the display of the <u>Document Library</u> on the SEMOpx website by introducing a more user friendly format, making it easier for website users to locate relevant documents.

Enhancements to the Document Library include:

- (1) A two tier "Refine by Category" display for the Document Library: Category and Subcategory
- (2) Multiple categories and subcategories can be selected at once
- (3) "Refine Results" button to be enabled for user once filters are set
- (4) Efficient results to be presented once filters are set
