1. SEMO UPDATE

Secretariat welcomed all to Exchange Committee Meeting 10. It was advised that elections for the SEMOpx had completed and a welcome was given to all Members. Feedback from the previous meeting has been taken on board with pro-active communication processes and housekeeping Proposals in development. Finally, it was noted that version 5.0 of the SEMOpx Rules and Procedures had been published in August and version 6.0 would commence in the new year.

3. DEFERRED MODIFICATIONS PROPOSALS

SPX_02_22 UPDATES TO SEMOPX OPERATING PROCEDURES AS A RESULT OF COMPLEX ORDERS BEING REPLACED BY SCALABLE COMPLEX ORDERS

The Proposer gave a brief recap on the Modification Proposal noting that the driver was to improve efficiency of the algorithm. It was advised that updates were made to the Modification Proposal to provide clarity to MAV and mandatory field and v2.0 was published earlier in the year for Members to review. The Proposer went through the phases of the project noting a closure report was issued on what had been done and advising that the go-live date was the 16th November 2022.

There were a few observations made by Members and a request to standardise the approach on proposals going forward to make them easier to follow.

4. NEW MODIFICATIONS PROPOSALS

SPX_06_22 IDA FULL DECOUPLING SCENARIOS CHANGES

The Proposer went through the presentation giving a background of the Modification Proposal advising that work had been done to find different ways of protecting auctions. It was noted that regional procedures were reviewed and how they can be safeguarded.

The scenarios that cause decoupling were discussed along with the risks and consequences that could lead to an auction cancellation. The proposed solution was to extend deadline by 25 minutes which would give additional time to find a solution.

Support was given for this proposal by Members and a request was made to circulate a note to provide more clarity on the procedural change.

5. SEMOPX UPDATE

SEMOpx provided a general update on market activities. This included the following topics:

Operations

 Auctions occurring as planned and only one was cancelled in May on IDA2 – prices in market are much higher with energy crisis. Everything is under control – money is flowing. Future Projects

- Greenlink new interconnector due on Q2 of 2024. Started construction. Financially underway.
- 30 min MTU Push from European point of view aiming for 15-minute MTU.
- Celtic another interconnector 700 megawatts. Predictions target Q4 2026. Impact from market would be linked into continental Europe access to order books. Extra capacity available Releases new functionality and updates to trading systems – highlighted.
- LRMBC no further update. TSOs were expecting to receive further instructions on what the next steps were. EU point of view no further details on that.
- Energy crisis EU regulation coming into force market price.

Actions:

- SEMOpx to check with RAs on decision on trading arrangements consultation by RAs Open
- SEMOpx to check on communications with DECC on energy crisis measures Open
