#### 1. SEMO UPDATE

Secretariat welcomed all to Exchange Committee Meeting 14 thanking all who nominated for the SEMOpx Elections and welcomed all new Committee Members and Alternates.

#### 2. NEW MODIFICATIONS PROPOSALS

#### SPX\_03\_24 MULTIPLE AUCTION TRADING SYSTEM (MATS) IMPLEMENTATION

Proposer provided a presentation on this Modification Proposal for the new MATS trading system noting that this would replace the existing ETS system and the DAM 30 min MTU implementation will be conducted on this MATS platform.

The Proposer listed the 4 main changes to SEMOpx Operating Procedures. A number of examples were given on the new offer curves that would be available, as well as the additional minor changes to incorporate MATS into the Operating Procedures. Finally, the benefits the MATS system would bring were outlined. It was noted that the platform would be a web-based application and there would be a new API standard. Assurance was given that there would be a number of supports given in terms of specifications, training and testing opportunities for the new system and the API.

Questions were raised around ETS testing and the roll back plan if needed. The Proposer agreed to take an action to discuss this with the project team and provided assurance that MATS will be well tested prior to deployment mitigating any risks. It was also queried if the system would cover just DAM or would the existing intraday auctions be included. SEMOpx confirmed all ex-ante auctions (DAM and IDA) would be included in MATS.

There was clarity sought on the testing for the timing scenarios and if go live dates were expected to be met. SEMOpx advised that there was no go live date yet confirmed, although the target currently was end of Q1 or Q2, but this is dependent on the timing of the 30 min MTU go-live. An update would be provided in December.

### 3. SEMOPX UPDATE

The SEMOpx team provided an update on enhancements to the market related to the ex-ante markets. Details were provided in the SEMOpx Exchange Committee Supporting Presentation which was distributed to Exchange Members on Tuesday, 12<sup>th</sup> November 2024.

The key dates mentioned were:

- SPX\_02\_24 Removal of 2<sup>nd</sup> Auction Process implementation is targeted for 29<sup>th</sup> January 2025 go-live.
- Greenlink Interconnector is now targeted (updated since slides issued) for commercial go-live on 26<sup>th</sup>
   January 2025.
- MATS targeted for end of Q1 or Q2 2025 (tbc).
- 30 min MTU currently targeted for 18<sup>th</sup> March 2025, but subject to successful SDAC testing.
- Strategic Markets Programme (SMP) target go-live Q4 2026.
- Transfer of Units functionality now live.

#### 4. AOB

The Secretariat thanked all for attending and noted that the next meeting is provisionally scheduled for Thursday, 8th May 2025.
