## 1. Introduction

The Trading on Behalf (ToB) process aims to be a supporting tool when isolated issues occur disrupting your connection with the MATS system. In this case, you can download the excel forms from our website for the respective auction from this link: [here](#).

This procedure provides all the details and steps to be followed for the ToB process.

The ToB process is meant to be operated on a best effort basis.

Firstly, please send us your forms filled in via email, then call the Market Operations Department immediately (Contact information can be found [here](#)). The goal is to ensure that your request is treated with high priority.

**This procedure is available for both SDAC and SEM-GB auctions.**

## 2. Business process

Below you will find the instructions on how to fill in the form and how to send it to the Market Operations Team for validation.

The form must be sent 15 min before the gate closure time at the latest. After that time, orders will only be accepted on a best effort basis.

SEMOPx's members must send us the form by email (Contact information can be found [here](#)) as soon as possible, to ensure it is processed efficiently and on time.

### 2.1 Download the excel forms from our website

Use the file available on the [SEMOPx website](#) to request the ToB process.

Please be ensured to select the correct MATS Bidding Form file based on the type of order:

- Linear Order
- Scalable Complex Order.


Please be careful to select the correct format:

- Normal Day => Select 1<sup>st</sup> Tab
- DST 23 => Select 2<sup>nd</sup> Tab
- DST 25 => Select 3<sup>rd</sup> Tab

## 2.2 Filling of the excel form

Once the TOB forms are downloaded, fill-in the excel file with the information below:

- Trader Name: **only authorized traders** are allowed to send a ToB form and request its submission
- Portfolio to be used: MATS Portfolio Name
- Action Type: New Order, Modification, Cancellation
