# SPX\_02\_25 IDA1 and IDA2 Local Auction Cancellation Deadline

#### Background to SPX\_02\_25

- Post Brexit, the IDA1 and IDA2 auctions are key auctions for market coupling between SEM and GB
- SEM-GB NEMOs and TSOs have been looking at ways to further protect the execution of these coupled auctions which may lead to decoupling
- SPX\_06\_22 (IDA Full Decoupling changes) modification submitted & approved.

#### SPX\_06\_22 Change

- To re-categorize the Full Decoupling due to cross-zonal capacity related reasons from a Full Decoupling to a Partial Decoupling – mitiigate th risks of Full Decoupling
- To extend the timeframe for the Full Decoupling due to technical reasons deadline for both auctions by 25 minutes and provide a local auction (in the event of decoupling)
  - IDA1 (19:15 GMT) / IDA2 (09:45 GMT)

#### SPX\_02\_25 Background

- Local Auctions will be facilitated for both IDA1 and IDA2 in the event auction publication does not occur by the Full Decoupling Deadline
- Local Auction Cancellation deadlines had also been identified (in the event auction publication does not occur by a set time)
  - IDA1 (20:00 GMT) / IDA2 (10:15 GMT)
  - Deadline previously agreed with EPEX, the SEMOpx service provider, as part of the SPX\_06\_22 modification request
  - Rationale: ECC deadline to receive the trade file and process them for (IDA1 and IDA2) nominations
- SPX\_02\_25 now to include reference to the deadline for Local Auction completion, before Local Auction Cancellation is initiated
- Outlined in sections E.2.3.1 (IDA1) and E.2.3.2 (IDA2) addition of the cancellation deadlines (outline above)



# SPX\_03\_25 Housekeeping mod to remove references to Schedule A.2 from SPX\_01\_21

## **Background**

- Post Brexit and following the implementation of SPX\_01\_21, Schedule A.2 is no longer applicable in the SEMOpx Operating Procedures
- This modification proposes to remove any outstanding references to Schedule A.2
- Changes are limited to SEMOpx Operating Procedures. No updates to the SEMOpx Rules and Glossary documents required

# **Proposed Changes in SEMOpx Operating Procedures**

- Removal of references to Schedule A.2 in sections A.1.1.5
- Removal of section B.3.2, which references Market Coupling Contracts in the Day-Ahead Market

# **SEMOpx Updates**

### MATS (Multiple Auction Trading System)

 New Trading system MATS is now live since August 28th and has successfully replaced ETS.

### 30 MIN MTU

- DAM 30Min MTU in the SEM went live on the 30th September 2025 (for delivery date 1st October 2025).
- This project was successfully implemented as part of the Single Day-Ahead Coupling (SDAC) 15-Minute MTU Programme, which was a collaborative NEMO and TSO Programme implemented across all European bidding zones and bidding zone borders.



# **SEMOpx Updates**

### SEMOpx Product Consultation

- Identified several products to introduce to SEMOpx members
- Initiated a Product Consultation process, to engage with members throughout to get their feedback on potential products
- Workshop held on 23rd September, outline product detail and future project timelines
- Member inputs required to determine product selection and testing configuration (at SDAC)
- Member Readiness scheduled to being in Q1 2026, Product go-live Q2 2026

### Strategic Markets Programme (SMP) & Multiple NEMO Arrangements (MNA)

- SMP: Re-Integration to SDAC, Integration to SIDC (EU IDAs & XBID)
- MNA: Allowing multiple power exchanges to offer services in ex-ante markets in SEM

#### **SMP Project**

- submitted Re-Integration requirements to SDAC, SIDC, CORE and ANDOA
- Testing timelines under discussion with LIP (Local Implementation Project) members

#### **SEMOpx**

- Scoped deliverables for SEMOpx related to implementation of SMP and MNA
- SMP and MNA change requirements confirmed with SEMOpx service providers (ECC & EPEX) and working groups formed to implement.
- SEMOpx assessing MNA implications on SEMOpx business with view to discuss with RAs and implement changes necessary.
