## 2 NEW MODIFICATIONS PROPOSALS

### SPX\_02\_25 IDA1 AND IDA2 LOCAL AUCTION CANCELLATION DEADLINE

Proposer provided a [presentation](#) on this Modification Proposal noting that following Brexit, SEM-GB, NEMOs and TSOs have been looking at other ways to protect the execution of both coupled auctions which may lead to de-coupling. The aim of the proposal was to safeguard the trading capabilities of Members. The Proposer gave an overview of what had previously been achieved with SPX\_06\_22 and a background on what this proposal would update.

It was noted that deadlines for cancellation of the local fallback auctions were already approved but not included in the change request. It was also advised that

SEMOpX provided an update on the below items noting more substantial mods likely to come next year as SEMOpX prepares for SMP & MNA.

#### **MATS**

SEMOpX advised that this project was completed back in August 2025 and noted a successful go live.

#### **30 Minute MTU**

It was noted that that this was deployed in September 2025 and operated as expected.

#### **SEMOpX Product Consultation**

SEMOpX noted that this concerned improving the range of products available to the market, especially renewable products. There were several products identified for this consultation and a Workshop was held in late September to get more information and detail. SEMOpX welcomed feedback from Members as it greatly helped when submitting the products for review with our service provider.

#### **Strategic Markets Programme (SMP) & Multiple NEMO Arrangements (MNA)**

SEMOpX advised that testing timelines were under consultation. It was noted that the original plan was scheduled for Q4 of 2026 but an update was given by Future Markets that re-planning of SMP was Underway and no update on revised dates had been given to date. It was advised that at present, SEMOpX were scoping out deliverables and carrying out assessments of what will be required for MNA. To date, a secure members area within the SEMOpX website was implemented which contains items such as technical project details, approved and published statement of charges and other commercially sensitive documents.

SEMOpX welcomed Fiona Briton, the new SEMOpX Account Manager to the SEMOpX team.



SEMOpx noted that November's meeting was light in terms of Proposals, but May 2026 could see more detailed Proposals submitted in relation to EU Integration.

The Secretariat thanked all for attending and noted Yearly Schedules for 2026 would be circulated shortly.
