Terminology

Client: Program or application acting as a client of the AMQP server.

Trader: Person that logs into the client to participate in the market.

Balancing Phase: Additional trading phase which starts after the end of the normal trading phase and ends in relation to delivery start. Normal orders from market participants can be entered but cannot trigger a trade execution. Only balance orders can trigger a trade execution (balance order entry is usually limited to one specific member). The order book can be crossed during the balancing phase.

1 Introduction

This document describes all M7 messages and errors that are provided by the backend system. The major focus is set on the events that trigger a message or an error, message arguments and the corresponding visibility.

The messages are broadcasted via a Broadcast channel by the backend. Two major groups of messages exist. Private messages are sent only to a particular user. On the other hand, public messages are broadcasted to all users without any restrictions. In addition, the messages are generated by different parts of the system (e.g. XBID, M7 and ComTrader). This document only describes those messages that are directly related to M7.

The messages, as well as the errors are distinguished based on their origin. Thus, only the errors related to M7 are considered in this document.

For more details about the communication with the backend system, protocols, etc. please refer to the *DFS180 - M7 - Public Message Interface* document.
